#Mililani50 Social Media Photo Contest Rules and Restrictions – Updated: 10/01/18

1. **ENTRY:** No purchase necessary to enter or win. Contestants will enter by submitting photos via Facebook or Instagram with #Mililani50. Photos must have been taken in Mililani sometime from 1968 to the Present. Contest Period is from November 1, 2018 to November 21, 2018. Submission Deadline is 5 PM HST on Wednesday, November 21, 2018. 1st, 2nd, and 3rd Place winners will be selected. Limit one (1) entry per person. For Facebook / Instagram Posts, please make sure your account is set to Public, posts by Private accounts are not viewable for consideration.
2. **ELIGIBILITY:** This contest is open only to legal U.S. residents, of any age.
